- (iii) booking a service through one of our hubs in Port Sudan, Gedaref, Kassala, Dongola (the "Hubs")

(v submitting an Order Form from the One Stop Shop; and/or

(iv) using the Content or Services in any way.

# Welcome to One Stop Shop (OSS)

These Terms of Use ('Terms') govern your access to and use of the One Stop Shop Services, a product by One Stop Shop, currently a brand under 249Startups and in the process of being registered as a company under the Sudanese Companies Act 2015.

## 1. About OSS

OSS is a centralized business hub, offering Sudanese entrepreneurs, startups and MSME a wide range of curated services through the Platform and through the Hubs.

Currently in the Soft Launch phase, it offers a limited selection of services that may include:

- 1:1 consultations in marketing, business development and legal
- insurance service packages
- · design services

Note: Some services are provided by 249Startups employees, some services are provided by trusted, trained and contracted service providers

# 2. Eligibility

You must be at least 18 years old and legally capable of entering into a binding agreement. By using the Platform, you confirm that you meet these criteria.

## 3. Account Registration

All services require you to provide personal and/or company information. In the following names as "registration details".

You agree to:

- Provide accurate, complete, and up-to-date information
- Maintain the confidentiality of your login credentials
- Notify us immediately of any unauthorized use of your account

## 4. Services

- 1. The OSS offers 2 types of services:
- (i) Service Package with a fixed price
- (ii) Customized Service Request
- 2. Client can see all available services and prices on the Platform or can ask about them in the Hubs and through the AI Business Assistant and Support Whatsapp-Number
- 3. All services have a clear description of a duration and content that the OSS will deliver. For any request from the client that goes beyond that, the client needs to book an additional service
- 4. Every service booking requires information from the clients to provide. This helps the expert to prepare well.
- 5. Each service will lead to a 1:1 interaction with our expert. Therefore, you will be asked to select a timeslot shortly after you submitted your service booking to meet our OSS experts.

## 5. Payments

1. Before Clients can buy a services, their Wallets needs to be filled with "points". These points are equal to the SDG amount the client transfers to the OSS.

- 2. Payment is made via bank transfer to a Bank of Khartoum account. Transfers can be made from any Sudanese bank, under any account name. The transfer subject must include 'OSS'
- 3. Client is requested to share a proof of payment, e.g. a screenshot of BANKAK transfer
- 4. The Payment will increase the "Wallet" of the Client. This Wallet can be used to pay the services.
- 5. If you filled your wallet with money and you do not want to use it anymore to buy OSS services with it and you want to get these points back to your bank account, please send a request with your name and email and phone number to support@ossbusiness.com

## 6. Discounts

- All services are visible with their original price. Discounts are done through the Wallet. If the client is granted a discount, the discount amount will be topped-up to your Wallet, so you can use it to buy services.

#### 7. Cancellation Rules

The client cancels by submitting an email to <a href="mailtosupport@ossbusiness.com">support@ossbusiness.com</a> or via Whatsapp to +249 91 073 3044 including your name, the service you booked, the meeting you scheduled.

- 100% refund: if canceled before you select the timeslot that the experts provide you.
- 50% fee: if canceled between 24 hours before the scheduled meeting
- 70% fee: if the client does not show up to the scheduled meeting

Rescheduling: free for the first time, 1000 SDG fee for the second

#### 8. User Conduct

You agree to use the Platform only for lawful purposes. You must not:

- Use the Platform for fraudulent or illegal activities
- Attempt to interfere with the Platform's functionality
- Impersonate others or provide false information
- Share account credentials
- Use access credentials beyond assigned Permitted Users
